7. The Leadership Team has recruited a committee of at least two appropriately trained volunteers not on the leadership team.
8. The Leadership Team encouraged participation in the Council's annual giving campaign (Leadership for a Lifetime) by letting the girls set and reach or exceed a goal.
9. A current Financial Report (F-31) is on file.
10. The leadership team ensures that programs include the National Program Portfolio (Journeys and Girls Guide to Girl Scouting) and the Girl Scout Leadership Experience (GSLE).
